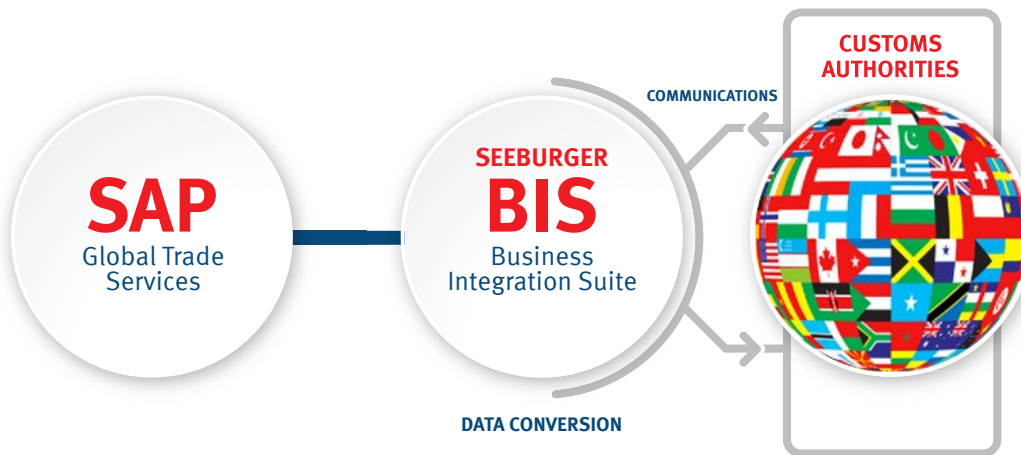


SAP GTS partnership for B2B/EDI Customs Communications
